February 9, 2023 5:30 Meeting

Devotions by Pastor and Council

The meeting was called to order by President Tim Kenyon with the following members in attendance: Gary Boschee, Mike Linch, Raquel Linch, Sherri Nissen, Deb Pantini, Claudia Peppers, Sandi Sickels, and Chuck Taylor. Randy Cook, Andy Hitz, Chris Lane, Emma Pantini, and Pastor Evan were absent.

Approve the agenda: M/S/C by Mike Linch and Sandi Sickels

Approve January council minutes: M/S/C by Claudia Peppers and Deb Pantini with the following corrected changes in spelling of Deb and Emma Pantini's names, as well as Chuck Taylor is unable to run a new term. This is under New Business – C.

Treasurer's Report by Mike Linch

All bills are paid, and everything is current.

Old Business:

Sound Barriers – Dorothy McNaught was not in attendance. Council had previously decided not to proceed with sound barriers.

The 2023 budget presented to council for review was \$152,188.00, which did not include an increase for Pastor.

In 2022, \$129,000 had been budgeted, including an \$8,000.00 short fall. Salem ended 2022 with a loss of \$16,000.00

M/S/C by consensus of the council, we request additional funds of \$10,000.00 from the Endowment fund in order to help cover the budget shortfall. This will allow a \$2,400.00 increase in Pastor's housing to \$16,800.00. The proposed budget for 2023 is \$154,588.60.

Reminder committee reports were due in the office by the end of January (Please get these in)

Outgoing Council members: Andy Hitz, Claudia Peppers, and Chuck Taylor. Sandi Sickels can serve a 2^{nd} term, and Raquel Linch is finishing Chris Lane's previous term.

Background checks: nothing to report.

Method of purchase for new supplements: Brenda will order as discussed with shipping covered by private donation.

Use of facilities by Narcotics Anonymous: no longer needed as they have found an alternate space.

Contract with Green Valley Pest and Fertilizer: M/S/C by Claudia Peppers and Deb Pantini to accept the years contract of approximately \$1,000.00.

Insurance: the current company is changing the policy and price. This will automatically renew May 1, 2023. A new quote has not been given at this time. Chuck Taylor is meeting with another company to have a comparison. He will report back at the March meeting.


